- 5. That Club may revoke my Annual Pass at any time upon thirty (30) days notice for any reason, in which event Club shall provide a pro-rated refund of prepaid, unused fees.
- 6. That my Annual Pass does not afford me any right or interest in Club or the Club facilities, is not transferable or assignable, and does not afford me any privileges beyond the period of time identified above.
- 7. That all payments of the Annual Pass fee are non-refundable.

8. That the Club facilities are a daily fee club, open to the public, and tee times may not be available as a result. Further, Club reserves the right to close the Club facilities, without notice, for, among other things, maintenance and PGA TOUR events. 9. That I will be liable for starting reservations that are not properly canceled per the Club's cancellation policy. 10.
