**TERMS AND CONDITIONS**

The undersigned (hereinafter, "I" or "me") hereby make application to the TPC Louisiana ("Club") Annual Pass Program and understand and agree:

1. To abide by the Rules and Regulations of the Club as they now exist or may hereafter be amended. I acknowledge that I have received a copy of the current Rules and Regulations.
2. That as a participant in the Annual Pass Program, I hold a mere license (an "Annual Pass") that entitles me to access and use the Club facilities, subject to certain restrictions, for a period of one year, beginning \_\_\_\_\_, Date to \_\_\_\_\_, Date. My Annual Pass will renew automatically from year-to-year unless I notify Club in writing of my desire that it not renew at least ten (10) days prior to the end of the term of my Annual Pass. \_\_\_\_\_ (Initial)
3. To pay the Annual Pass fee, together with all applicable sales and amusement taxes, if any, due thereon, as follows:  
 Payable in:  one (1) payment of the total Fee Amount, due immediately; \$2,800 (\$3,045/inclusive of taxes)

I hereby authorize Club to charge my credit card for the purpose of guaranteed payment for advance starting reservations, (including tax, if any, due thereon). I agree to update my credit card information if it changes. I hereby release and discharge PGA TOUR, Inc., PGA TOUR Golf Course Properties, Inc., TPC Louisiana, their respective owners, operators, and each of their respective affiliates, subsidiaries, officers, directors, and employees, from all damages, liabilities, and/or costs associated with the charging of such amounts and in the possession of this information. In the event that my credit card is declined for any reason, Club reserves the right to cancel Annual Pass privileges and/or pursue collection of any amounts owed.

4. That Club may revoke or suspend my Annual Pass, without refund and without notice, for my failure to make payment timely of any amounts due Club, for violation of any of the Rules or Regulations by me or my guests, for reason of my or my guests' conduct or behavior being a nuisance, disturbance to others, (whether Club members, employees, or otherwise), disruptive, dangerous, or otherwise unacceptable to the Club. If my Annual Pass is revoked for any of these reasons, I may not re-apply for an Annual Pass for at least twelve (12) months following the date of revocation.
5. That Club may revoke my Annual Pass at any time upon thirty (30) days notice for any reason, in which event Club shall provide a pro-rated refund of prepaid, unused fees.
6. That my Annual Pass does not afford me any right or interest in Club or the Club facilities, is not transferable or assignable, and does not afford me any privileges beyond the period of time identified above.
7. That all payments of the Annual Pass fee are non-refundable.

- 8. That the Club facilities are a daily fee club, open to the public, and tee times may not be available as a result. Further, Club reserves the right to close the Club facilities, without notice, for, among other things, maintenance and PGA TOUR events.
- 9. That I will be liable for starting reservations that are not properly canceled per the Club's cancellation policy.
- 10. That any and all amendments to this application and agreement shall be in writing.
