



EXECUTIVE SUMMARY CORPORATE MEMBERSHIP

Member Privileges:

Local

75% years 1-3; 50% years 4-6; 25% years 7-9; 0% years 10 or later.
- Membership Deposit term is 30 years. Upon expiration of deposit term, the Club will repay to the Member the Membership Deposit amount upon surrender of Deposit Certificate and provided the Membership has remained in good standing throughout the entire period.
- Refundable at maturity of deposit term.
- 2017 Annual Dues: \$6,895 plus applicable taxes per Designee Member.
- No food or beverage spending minimum.
- No capital assessments.
