TERMS AND CONDITIONS

The undersigned hereby makes application for the TPC Scottsdale’s TPC Pass and understands and agrees:

_____ TPC Scottsdale is a daily fee, public facility and reserves the right to change its Program’s rules, rates and regulation at any time without any notice.

_____ TPC Pass Holders (“Holders”) and Holders’ guests must abide by TPC Scottsdale rules and regulations at all times. Failure to do so may result in the immediate termination of the Pass without refund.

_____ TPC Scottsdale may remove Holder’s TPC Pass without cause at any time upon thirty (30) days’ notice for any reason, in which event TPC Scottsdale shall provide a pro-rated refund of prepaid, unused fees based upon the number of months remaining before the TPC Pass would otherwise expire.

_____ Tee times booked outside the booking window will be booked at the posted rack rate. Times may not be made outside the booking window, canceled, and re-booked inside the booking window.

Booking Window: Stadium Course: 3 day year round
Champions Course: 3 days year round

_____ TPC Pass discounts cannot be applied with any other promotional rates, specials, or discount offers.

_____ Holders must register in the golf shop prior to their starting time to pay all applicable fees.

_____ TPC Pass Holder will be charged for 1) tee times for which there are either no players (no show) and 2) for tee times in which the number of actual players is less than the number of players booked. In these instances, the TPC Pass Holder’s credit card on file will be charged the TPC Pass Holder rate for all “no-show” players. Non-compliance may result in Holders cancellation with no refund.

_____ Discounted guest fees, provided to one guest per tee time on the Stadium Course, and three guests per tee time on the Champions Course during the seasons specified below, will apply only to guests accompanied by the Holder. These guest fees shall be the same fees offered to the TPC Pass Holder, excluding the cart fee only rate after 2:30pm. Should the Holder not be present, guests will pay the posted rack rate.

Discounted Guest Privileges: **Stadium:** 3 guest year round
 Champions: 3 guests year round

_____ TPC Pass is non-transferable and non-assignable. Program benefits and privileges shall not be extended to any individuals other than the Holder.

_____ TPC Pass is void 5 weeks past renewal date and the passholder must purchase a new TPC Pass.

_____ TPC Pass expires December 31st, 2021.

_____ Rate for after 2:30 will be: **Stadium:** Post overseed thru May 23rd - \$75 May 24th – overseed \$39
 Champions: Post overseed thru May 23rd - \$49 May 24th – overseed \$31
 (Rates subject to change throughout the year)

_____ All Annual Pass Holders and Designees shall respect and treat with dignity other Annual Pass Holders, Designees, Guests and Club employees. In particular, Annual Pass Holders shall not engage in offensive, harassing or other inappropriate conduct. Such behavior is inconsistent with the Club’s philosophy of mutual respect for all. Violation of this policy by any Annual Pass Holder, Designee(s), their Immediate Family Members, or their Guests could affect membership privileges.
