TERMS AND CONDITIONS

The undersigned hereby makes application to the TPC Scottsdale (“Club”) Annual Pass Program and understands and agrees:

_____ As a participant in the Annual Pass Program, I hold a mere license (an “Annual Pass”) that entitles Annual Pass Holder (“APH”) to access and use the Club facilities, subject to certain restrictions, for an initial period of one year, beginning _____, 2021 to ___December 31, 2022.

_____ TPC Scottsdale is a daily fee, public facility and reserves the right to change its Program’s rules, rates and regulations at any time, without any notice.

_____ APH and APH guests must abide by Club’s rules and regulations at all times. Failure to do so may result in the immediate termination of the Annual Pass without refund.

_____ Club may remove APH’s Annual Pass without cause at any time upon thirty (30) days’ notice for any reason, in which event Club shall provide a pro-rated refund of prepaid, unused fees.

_____ Tee times booked outside the booking window will be booked at the posted rack rate. Times may not be made outside the booking window, canceled, and re-booked inside the booking window.

Booking Windows:

Annual Pass: 5 days

_____ Annual Pass discounts cannot be applied with any other promotional rates, specials, or discount offers.

_____ APH must register in the golf shop prior to their starting time to pay all applicable fees.

_____ All practice shall be confined to Club's designated practice areas as designated below. There is no access to TOUR player practice areas (West End) or instructional areas. Any guests using the practice facilities (not in conjunction with a booked tee time that day) will be required to pay the applicable practice facility fees.

Practice Privileges:

Annual Pass: Champions practice facility year-round access with seasonal restrictions. Seasonal restrictions on Stadium practice facility**

**restricted from 1/1/2022 – 5/1/2021 & 10/23/2022– 12/31/2022 **

_____ Tee times must be cancelled at 72 hours in advance. APH will be charged 1) for unsold tee times cancelled within 72 hours; 2) for tee times which there are either no players (no show); and 3) for tee times in which the number of actual players is less than the number of players booked. In these instances, the APH's credit card on file will be charged for one APH fee and the remaining fees will be charged at the APH guest rate.

Noncompliance with the cancellation policy may result in termination of the Annual Pass without refund.

_____ Discounted guest fees apply only to guests accompanied by the APH. Should the APH not be present, their guests will pay the posted rack rate.

_____ Annual Pass is non-transferable and non-assignable. Program benefits and privileges shall not be extended to any individuals other than the APH.

_____ All Annual Pass Holders and Designees shall respect and treat with dignity other Annual Pass Holders, Designees, Guests and Club employees. In particular, Annual Pass Holders shall not engage in offensive, harassing or other inappropriate conduct. Such behavior is inconsistent with the Club's philosophy of mutual respect for all. Violation of this policy by any Annual Pass Holder, Designee(s), their Immediate Family Members, or their Guests could affect membership privileges.
