**TERMS AND CONDITIONS**

The undersigned hereby makes application to the TPC Scottsdale (“Club”) Annual Pass Program and understands and agrees:

\_\_\_\_\_ As a participant in the 87 Club, I hold a mere license (an “87 Club Pass Holder”) that entitles 87 Club Pass Holder (“87 er”) to access and use the Club facilities, subject to certain restrictions, for an initial period of one year, beginning \_\_\_\_\_, 2025 to \_\_\_December 31, 2025.

\_\_\_\_\_ TPC Scottsdale is a daily fee, public facility and reserves the right to change its Program’s rules, rates and regulations at any time, without any notice.

\_\_\_\_\_ 87 Club Pass Holders and 87 Club guests must abide by Club’s rules and regulations at all times. Failure to do so may result in the immediate termination of the Annual Pass without refund.

\_\_\_\_\_ Club may remove 87 Club Pass Holder without cause at any time upon thirty (30) days’ notice for any reason, in which event Club shall provide a pro-rated refund of prepaid, unused fees.

\_\_\_\_\_ Tee times booked outside the booking window will be booked at the posted rack rate. Times may not be made outside the booking window, canceled, and re-booked inside the booking window.

Booking Windows:

**Champions:** 14 days

**Stadium:** 14 days

\_\_\_\_\_ 87 Club Pass Holders discounts cannot be applied with any other promotional rates, specials, or discount offers.

\_\_\_\_\_ 87 Club Pass Holders must register in the golf shop prior to their starting time to pay all applicable fees.

\_\_\_\_\_ All practice shall be confined to Club's designated practice areas as designated below. There is no access to TOUR player practice areas (West End) or instructional areas. Any guests using the practice facilities (not in conjunction with a booked tee time that day) will be required to pay the applicable practice facility fees.

Practice Privileges:

**87 Club:** Champions practice facility year-round access with seasonal restrictions. Seasonal restrictions on Stadium practice facility\*\*

\_\_\_\_\_ Tee times must be cancelled at 72 hours in advance. 87 Club Pass Holder will be charged 1) for unsold tee times cancelled within 72 hours; 2) for tee times which there are either no players (no show); and 3) for tee times in which the number of actual players is less than the number of players booked. In these instances, the credit card on file will be charged for one Pass Holder fee and the remaining fees will be charged at the Pass Holder guest rate. Noncompliance with the cancellation policy may result in termination of the 87 Club Pass without refund.

\_\_\_\_\_ Discounted guest fees apply only to guests accompanied by the Pass Holder. Should the Pass Holder not be present, their guests will pay the posted rack rate.

\_\_\_\_\_ 87 Club Pass is non-transferable and non-assignable. Program benefits and privileges shall not be extended to any individuals other than the Pass Holder.

\_\_\_\_\_ All 87 Club Holders and Designees shall respect and treat with dignity other 87 Club Pass Holders, Designees, Guests and Club employees. In particular, Pass Holders shall not engage in offensive, harassing or other inappropriate conduct. Such behavior is inconsistent with the Club's philosophy of mutual respect for all. Violation of this policy by any Pass Holder, Designee(s), their Immediate Family Members, or their Guests could affect membership privileges.
